EIGHTH CALL FOR PROJECT APPLICATIONS IS OPEN!

The eighth call for BSR INTTEREG III B project applications was opened on 25 July 2005 and will be closed on **23 September 2005**.

This is the first call where: • project applicants can apply for Tacis and ERDF funding in one application, • measure 3.2. 'Bilateral maritime cooperation across the Baltic Sea' is open for the applicants.

In the running call projects can:

apply as a regular project with ERDF co-funding,
apply as a regular project with ERDF and Tacis cofunding,

 upgrade project with Tacis funding (only for projects approved in the sixth and seventh calls),

apply for Extension Stage Instrument (ESI) to the running projects,
apply for the Maritime Safety Umbrella Operation (MSUO) to the running projects.

The Steering Committee will meet in December 2005 to make approval decisions on the projects.

NEW ACTIVITIES AND INDICA-TORS INTRODUCED IN THE PROGRAMME

New activities as well as a new system of indicators have been introduced into our programme. The Monitoring Committee has decided on respective amendments in the Programme and Programme Complement. The amendments include:

 Project Extension Stage Instrument available for advanced on-going projects for investments (chapter 7.5 in PC).

• Financial upgrading of running projects to participate in the Maritime Safety Umbrella Operation (MSUO). The MSUO is coordinated by the North Sea INTERREG III B Programme (chapter 7.6 in PC).



• Introduction of a new system of indicators to be used in reporting of finalising projects (annex 3 of PC).

In addition, there are minor amendments on the financial tables of both Programme and Programme Complement. These concern Priorities 1, 4, 5 and 6. • Kuressaare, Estonia

EXTENSION STAGE INSTRUMENT TO THE RUNNING PROJECTS LAUNCHED!

The Steering Committee has endorsed an introduction of a so called project 'Extension Stage Instrument' (ESI). The instrument was approved by the Monitoring Committee at the end of August 2005 and is available for applying projects during the 8th call.

The Extension Stage is an instrument designed exclusively for already running BSR INTERREG III B NP projects. It allows for extending the project duration (until December 2007 at the

latest) in order to implement 'trans-national investments'. The principle character of a trans-national investment is that it has to be a result of trans-national co-operation. A detailed definition of this term is given in the Programme Manual, chapter 3.2.1. and in the Programme Complement, chapter 7.5 (both documents are part of the applicant's pack, see below). There, a list of selection criteria and rules for implementation of Extension Stage projects can also be found. >





 The most important features of the ESI are:
 it applies only to those projects that are still ongoing at least until December 2005, and
 have by then implemented

at least 50% of the planned milestones;

 projects can apply for the ESI only in the same measure as that of the original project;

 external funding (Tacis) is not available under the extension stage instrument;
 projects should not have had problems or major deviations with the implementation of the original project, in order not to endanger a successful implementation of the extension stage;

 as the extension stage is not a new project but merely a prolongation of the original project, the partnership originally established also remains the same as in the original project;

partners from at least
countries must be involved in the extension activities, out of which only one has to be financially involved in the investment itself;
a letter of support has to be signed from at least
other partners from at least
east 2 other countries.

MARITIME SAFETY UMBRELLA OPERATION

The Maritime Safety Umbrella Operation (MSUO) is an initiative across the INTER-**REG** programmes launched in the beginning of 2005 (www.maritime-safety.org) and hosted by the INTER-**REG IIIB North Sea Pro**gramme Secretariat. The aim of the MSUO is to create a synergy between INTER-REG projects from different programmes in order to identify similar maritime safety issues, problems in approach and gaps in the knowledge base as well as to stimulate future programme development.

In the Baltic Sea Region the initiative is regarded as one contributing to efficient and consistent maritime safety solutions as well as ensuring synergy effects between the initiatives of the various transnational programmes. To underline the interest of the Baltic Sea Region programme in the initiative, the chairman of the BSR INTERREG Programme Steering Committee, Mr Arve Skjerpen sent a letter on 18 August 2005 to the North Sea Programme Monitoring Committee chairman, Mr Friedhelm Budde, expressing support of the Partner States of the Baltic Sea Region Programme to the MSUO initiative.

Baltic Sea Region INTERREG III B Neighbourhood Programme participates in the MSUO via its projects. New projects can apply for participation in the MSUO following the standard procedures of the main call for proposals. In addition, also ongoing projects can participate through application for a special project upgrade We suggest that projects that are interested in applying for the ESI start their preparation a.s.a.p. Applications are admitted until 23 September 2005. The applicant's package IV for the ESI can be downloaded at <u>www.bsrinterreg.net/</u> <u>toapply.html</u>. The submitted proposals will undergo a regular assessment and approval procedure during the 8th application round.
