# Russian proposal on indicative allocation of Tacis funding between priorities and measures of BSR Interreg III B Neighbourhood Programme

Based on the decisions of

RNSC Task Force meeting, St. Petersburg, 26 March 2004 and consultations with RNSC members from all North-West regions of Russia during 26 of March – 15 of April.

### BACKGROUND

The proposal for **ERDF allocation** between priorities and measures was developed by Steering Committee "Strategy" Task Force on its meeting 11-22 March

The Steering Committee Task Force also developed recommendations **on Tacis NP Funding**, Please see below:

Abstract from the Minutes of First Steering Committee "Strategy" Task Force on Allocation of funding between measures

The TF recommendation is that the NP funds will not be allocated between the measures. However, if this is envisaged, there exist two options, either following the allocation rates of the remaining INTERREG III B funds or **to set specific financial priorities to be proposed by Russia and Belarus**. The final decision on the issue will have to be taken by the MC and the COM.

### RNSC TASK FORCE PROPOSALS ON TACIS NP FUNDING

#### 1. RNSC Task Force is proposing specific financial priorities based on the following principles:

- Provide relevant financial basis to measure 3.2. for the participation of Russian partners in bilateral co-operation which will be in balance with ERDF allocation
- Not to introduce new priorities and allocations for every measure
- To be in line with IR III B ERDF scheme

**Decision:** I to allocate **50%** of Tacis Funding to **Priority 3** with 40/60 distribution between 3.1 and 3.2 was approved by the RNSC Task Force members. Also **5%** should be allocated for Priority 7. Technical Assistance. **According to this decision the RNSC Task Force developed the following proposal**:

#### 2. RNSC Task Force proposing the following size of Tacis grants

- minimum amount: EUR 100.000
- maximum amount: EUR 300.000
- **3.** Under the conditions of closing Seed Money instrument just in the moment when the Neighbourhood Instrument is introduced **RNSC Task Force proposing to allocate 10%** (within every priority) **to micro-grants for projects preparation.** Size of Tacis micro-grants up to 25.000 EUR.

## 4. RNSC Task Force proposing following definitions for eligible partner organization under Bilateral Maritime Co-operation

Project proposal should be prepared in a partnership between partner organizations as specified hereafter. A partnership is a relation of substance involving an active exchange of skills, experience and knowledge. All partners of a project must be involved in its designing and conception, and actively participate in its implementation.

One of the project partner organizations should act as a lead partner. The lead partner is the partner in charge of smooth running of the project and its implementation, and bears financial and legal responsibilities to the programme managing and paying authorities.

In order to be eligible for the bilateral maritime co-operation, partner organizations must be a non-profit-making legal entity falling within the following categories:

- Local and regional authorities (cities, municipalities, province or regions);
- An association of local/ regional authorities;
- An entity closely linked to a local or regional authority as part of the organizational structure or/and mainly owned (minimum 50%) by this local/regional authority, or having an administrative, managerial or supervisory board, more than half of whose members are appointed by the State, regional or local authorities or by other bodies governed by public law;
- Non-governmental organizations;
- Not-for-profit professional organizations (associations of SMEs, chambers of commerce, trade associations, etc.);
- Regional branches of national/federal bodies relevant for the project
